

**Bishop Creek Water Association
Meeting Summary
July 5th, 2016**

I. Opening and Introductions

The BCWA meeting was opened at 7:07 p.m. Trustees in attendance included: Gene Coufal, Henry Means, Rock Baker and Greg Loveland. Watermaster Chas Coufal and Bert Almond were in attendance as well. Trustee Merry Armstrong was absent.

II. June 7th, 2016 Meeting Summary

The summary of the June 7th, 2016 Monthly Meeting was reviewed and approved as written.

III. Financial Reports

The Financial Report for June 2016 was reviewed and approved.

IV. Report on North Sierra Highway Specific Plan

Josh Hart, Inyo County Planning Department, and Tom Schaniel gave a presentation concerning the North Sierra Highway Specific Plan. They prepared a handout for distribution among the BCWA members. They presented the 5 year breakdown of the proposed plan and funding. After year three a decision would be made on whether to continue with the project. A public meeting will be held on July 21st, 2016 at Northern Inyo Hospital in the board room at 6:00 pm.

V. Bishop Creek Flow and Storage Report

Flows in Bishop Creek increased significantly due to Sabrina Lake spilling. A hydrograph (attached) was provided in the packet to illustrate the higher flows. South Lake continues to rise and is presently up to the toe of the dam.

VI. Old Business

- a) Gene Coufal reported that the BCWA Board met with Inyo County Supervisor Rick Pucci, Inyo County Administrator Kevin Carunchio, and Inyo County Water Department Director Bob Harrington to discuss the high ground water issues in West Bishop on June 20th. As an outcome of the meeting, Inyo County contacted the California Office of Emergency Services and held a conference call with the California Department of Water Resources on June 24, 2016 to discuss the ground water concerns. DWR will visit the area to assess conditions through the coordination of Bob Harrington. The site visit is scheduled for July 6-7 and DWR is expected to complete a report with their findings.
- b) Rock Baker provided the attached letter from Patricia Gardner and John Lammiman. The letter gave their concurrence to reactivate the

ditch located on the west side of 2766 Sunset Rd, Bishop, CA for the purpose of providing water to the north side of Sunset road.

VII. Water and Arbitration Committee Report

No formal meeting: Report submitted by Rock Baker

- o Street meeting for Carol Lane scheduled for July
- o Property owner on Sierra Street ditch doing repair. He will advise when complete. We will look to increase flow at that time.
- o Flow being cut on Highland drive to determine impact on impacted properties.
- o Conditions on Sunset are remaining the same.

VIII. Watermaster Report

Chas reported that the month went along with nothing out of the ordinary. He received 63 phone calls and 32 text messages during the month. The Sierra Vista Gate received a minor repair. He is looking into redesigning some gates and performing the work himself to keep the costs down.

Chas requested member to call him with any reports of gates and diversions being tampered with. The new structures are still being calibrated to figure out how the new flow schemes work.

IX. New Business

- a) Wayne Matlick requested a larger more consistent head of water. Rock stated that he will talk to Wayne after the meeting. A site visit was proposed and Wayne will lead.
- b) Roberta Macintosh requested that the ditch in front of the Inyo County Road Department on Line St. be cleaned before flows decline this fall.


X. Next Meeting

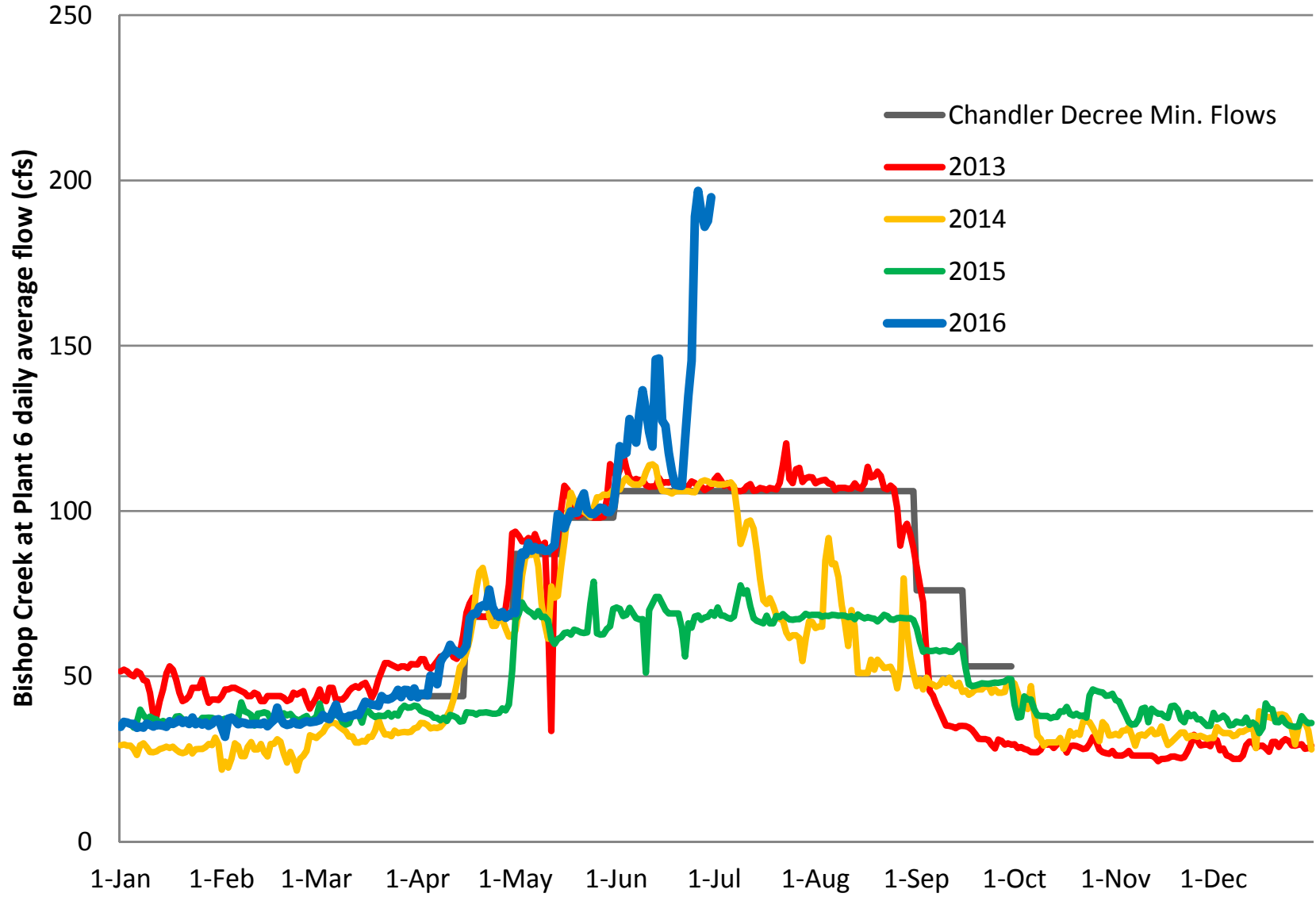
