#### Bishop Creek Water Association Monthly Meeting Summary August 14<sup>th</sup>, 2018

#### 1. Opening and Introductions

The BCWA meeting was opened at 7:00 p.m. Trustees in attendance included: Gene Coufal, Eric Tillemans, Henry Means, Don Kunze and Merry Armstrong. Watermaster Matt Durkee was present.

**2.** Approval of the June12, 2018 and July 10, 2018 Monthly Meeting Summaries The monthly meeting summaries for June 12, 2018 and July 10, 2018 were approved unanimously.

#### 3. Financial Report

The financial reports for June 2018 and July 2018 were reviewed and approved unanimously.

#### 4. SCE's Bishop Creek Relicensing

Matt Whithall, SCE Project Manager for Relicensing, two consultants and three SCE employees were present. Matt reported that SCE is required to renew its license every 30 years and their current license will expire in 2024. SCE expects that the relicensing process will result in no operational changes on Bishop Creek.

The renewal process involves outreach to explain new license application to parties that are affected. The formal process will begin next March.

#### 5. Eastern Sierra Runoff and Bishop Creek Flow/Storage Report

SCE personnel reported that with the wet spring/summer they were able to keep their reservoirs full much longer than expected and should have no problem maintaining the flows they planned on this fall and winter periods.

#### 6. Old Business

a) New Landscaping at 200 S Mountain View Rd, McLaren: Don, Gene, and Matt looked at the pond lining and found it to satisfactory. Diverting from one ditch and returning it into another is a violation of the BCWA bylaws but in this case should be grandfathered in because it was an old existing system. The Board approved this on the condition that user install a lockable control structures that is managed by the Watermaster. Also, a concern was expressed regarding water seen flowing across the

driveway on the south end of the property. Gene will field check

- b) Low Flows at Vaults on Matlick Ditch at O'Reilly Auto Parts: The flows are still low. Gene and Chris met with the Tribe and looked at the condition of the Tom Key Ditch. The Tribe is going to prepare a proposal for the cleaning of the ditch and provide it within two weeks.
- c) Yaney Ditch Diversion Structure Repair/Replacement at: 1) SW Corner of Yaney & Hanby; 2) Diversion at Dog Park
  - 1) DWP will replace this winter.
  - 2) Matt is working on installing a new control structure.

- Problem with a blocked ditch between Highland and Sunset Rd w/o Barlow: Matt placed a letter but has not received a response yet. He will post a second notice.
- e) Leaking Pipe e/o Crosby St: The pipe is still leaking and the property owners are not members of the BCWA. Gene's opinion is that it is the property owner's responsibility to fix the leak. Gene will contact the City of Bishop to discuss.
- Ditch Diversion Box Repair/Rebuild Work: Gene reported no action but plans to begin working on phase 2.
- g) Collection of Past Due Assessments: The Board will review the list of late payers next month and decide a course of action. Currently 150 +/- members have not paid their 2018 assessments, and 114 members have not paid in over a year.

#### 7. Water and Arbitration Committee

#### 8. Watermaster Report

Throughout the month Matt received 36 calls and 15 texts. Matt reported that there was vandalism to the structure at the Gillette Property Split and that the sign was taken down within 24 hours of being installed. Matt replaced the sign. If the sign is vandalized again the sheriff will be called.

#### 9. New Business

- a) Nelligan Ditch Check Structure at South Mountain View Rd Diversion: There were several calls reported on the Nelligan Structure leak. Sand bags were placed to restrict further damage. The structure needs to be replaced.
- b) Other: No other new business.

#### 10. Next Meeting

The next meeting of the Bishop Creek Water Association will be on Tuesday, October 9th, 2018 at 7 pm at the Los Angeles Department and Water Power Office Building at 300 Mandich St.

#### 11. Adjournment

The meeting was adjourned at 8:09 p.m.


