#### Bishop Creek Water Association Monthly Meeting Summary November 13<sup>th</sup>, 2018

#### 1. Opening and Introductions

The BCWA meeting was opened at 7:02 p.m. Trustees in attendance included: Gene Coufal, Henry Means, Don Kunze, Merry Armstrong and Adam Perez. Watermaster Matt Durkee was present.

#### 2. Acceptance of the October 9th, 2018 Monthly Meeting Summary

The monthly summary for October 9<sup>th</sup>, 2018 was approved with the following change to Item 8c in New Business: The following was added to the end of sentence 2, "and construction of the pond will be consistent with the BCWA By-Laws." And sentence 3 was deleted since the meeting summary acts as documentation of the approval and conditions.

#### 3. Financial Report

The financial report for October 2018 was tabled to allow time for Henry to verify the transfer of savings to Union Bank and to get answers to questions on the report.

#### 4. Eastern Sierra Runoff and Bishop Creek Flow/Storage Report

SCE has been maintaining Bishop Creek flows around 62 cfs and will keep flow steady. Questions by the membership were raised as to the impact on Bishop Creek storages if SCE continues to release 62 cfs through the winter. LADWP will check with SCE to find out what they are planning.

#### 5. Old Business

- a) Low Flow at the vaults on Matlick Ditch at O'Reilly's Auto Parts: Flows down the ditch have continued to be low. Wayne Matlick reported that here is not enough water to sustain any stock in the field. He maintains that too much water currently is being diverted down Brockman Lane. Matt will talk to Chris Thompson to request more water in the Matlick Ditch at the two vaults. The board will set another meeting with DWP to discuss possible solutions.
- b) Problem with a blocked ditch between Highland and Sunset Rd W/O Barlow: No resolution to the issue to date. Don and Matt are following up on the issue.
- c) Yaney Ditch Diversion Structure Repair/Replacement at:
  - i. SW Corner of Yaney and Hanby: LADWP to rebuild the structures.
  - ii. Diversion at Dog Park: Matt has been using a board to divert flow, but it was recently removed. This could potentially need to be improved to incorporate a more permanent method of diversion.
- d) Flooding E/o Crosby St: The issue has been resolved.
- e) New Landscaping at 200 S Mountain View Rd in McLaren: The property owner has constructed a new control gate. Matt will install a BCWA lock.
- f) Ditch Diversion Box Repair/Rebuild Work: Gene presented a proposal to revise the work (due to unanticipated problems) and cost of Phase II. The

Board compared the work and cost estimate from 1/24/17 to a revised work and cost estimate prepared on 11/13/18. The board approved the revised Phase II work and cost.

g) Collection of Past Due Assessments: All but one of the past due assessments that received judgements in small claims court have been resolved. For the property that remains outstanding the Board approved moving forward with filing a lien against the properties.

#### 6. Water and Arbitration Committee

Don checked on the issue at Barlow and Sunrise. The water is being diverted off of the ditch, in to a pond and then returns back to the ditch. The Board discussed whether this was an issue for the BCWA or an issue between the property owners that need to be resolved by them. There is not an issue for the Board to act on at this time. Don will relay the decision to the property owner.

#### 7. Watermaster Report

Throughout the month Matt received 42 calls and 2 texts. If leaves become a problem through the Fall, give Matt a call.

#### 8. New Business

- a) Consider approval of new pond at 2677 Highland Dr.: The board does not police a property owner's decision to use water or to install a new pond. Per the BCWA By-Laws the depth and the lining practices are what the Board considers. A letter and drawing concerning the pond were circulated. The Board noted that the pond design calls for it to be lined and no more than 5 feet deep as called for in the By-Laws. The Board had no objections to the design and will follow up to confirm compliance when the work is completed.
- b) Other: New pond at 858 S. Barlow Ln.: The October 9<sup>th</sup> minutes were revised to reflect that the new pond needs to be consistent with the BCWA Bylaws.
- c) Obstruction of Ditch Flow at SW Corner of S Mtn View and Ranch Rd: A letter Mr. Gillette was drafted. It will be sent out this week.
- d) Mrs. Jarvis has requested that her property be taken off the membership roll as her property no longer receives water. The Board agreed. The upstream diversion structure will need to be dismantled.

#### 9. Next Meeting

The next meeting of the Bishop Creek Water Association will be on Tuesday, December 11<sup>th</sup>, 2018 at 7 pm at the Los Angeles Department and Water Power Office Building at 300 Mandich St.

#### 10. Adjournment

The meeting was adjourned at 8:16 p.m.


