### Bishop Creek Water Association Annual Meeting Summary January 28<sup>th</sup>, 2018

#### 1. Opening and Introductions

The BCWA meeting was opened at 7:02 p.m. Trustees in attendance included: Gene Coufal, Don Kunze, Merry Armstrong and Adam Perez. Trustee Henry Means was absent. Watermaster Matt Durkee was present.

#### 2. Acceptance of the January 8th, 2019 Monthly Meeting Summary

The monthly summary for January 8<sup>th</sup>, 2019 was unanimously approved as written.

#### 3. Annual Report

Gene gave a year in review report. Last year's snowpack ended up at 70% of normal. On the financial side the BCWA stayed on track of what was planned for the year. The capital work that was completed stayed within \$1,000 of what was budgeted and Phase 1 is completed. Phase II of the Capital Projects planned will continue this year and lead into Phase III during the fall and winter months.

A past due lien was placed on one parcel.

The approved meeting summaries for 2017 are posted on the website.

Flows is West Bishop were good overall throughout the year. There have been issues with getting water down the Matlick Ditch. The BCWA has been actively working with the LADWP and the Bishop Tribe to try and resolve the issue. The Yaney Ditch continues to be an issue. The BCWA will handle the issues around the Dog Park while the city will handle issues at Hanby and Yaney. To deal with the tampering of the Vista Ditch on Ranch Road, the BCWA will contact the property owner. And there are concerns that the Nelligan Ditch structure will fail and needs some repair.

Matt Durkee was hired as the permanent Watermaster.

## 4. Snow Pack, Precipitation, and Bishop Creek Flow and Storage Report Normal conditions present

#### 5. Old Business

a) Cleaning of the Tom Key Ditch on Reservation E/O Brockman: The Bishop Tribe prepared a proposal and bid. In the proposal the tribe agreed to enlist the help of a youth group from LA. The work will be done with and incremental approach to see how well it works out this year. The cost to the BCWA will be \$1,979 which the board approved.

#### 6. 2018 Financial Report

The board discussed the fees that were associated with transferring accounts form Bank of America to Union Bank. They also discussed the past due assessments from 2018. There were 43 members with past due assessments that totaled \$1,458.

#### 6. 2018 Financial Report

The financial report for 2018 was reviewed. Apparent confusion with the report was explained and was due to the transferring of accounts from Bank of America to Union Bank.

Also discussed were the past due assessments from 2018. There were 45 members with past due assessments that totaled \$1,458. There were 43 members with past due assessments prior to 2018 that totaled \$8,950. There will probably need to be continued actions in small claims court this coming summer to recover lost assessments.

#### 7. New Business

- a) Approval of 2019 Budget: One correction was proposed to the presented budget to include the expenses for cleaning the Tom Key Ditch. The budget included a \$25/ month pay increase for the Watermaster. The membership unanimously approved the Budget with the one correction.
- b) Election of Trustees: Gene Coufal and Don Kunze terms expired. Nominating Committee Chair, Steve Stevens recommended that both be re-elected. Both were willing to serve for another term. There were no nominations from the audience. Both Trustees were approved unanimously to serve two-year terms of 2019-2020.
- c) Other: The Cherry Lane Project was discussed. Watermaster Durkee will install a diversion structure in the C-Ditch to push more water in the direction of Cherry Lane.

#### 8. Next Meeting

The next meeting of the Bishop Creek Water Association will be on Tuesday, April 9<sup>th</sup>, 2019 at 7 pm at the Los Angeles Department and Water Power Office Building at 300 Mandich St.

#### 9. Adjournment

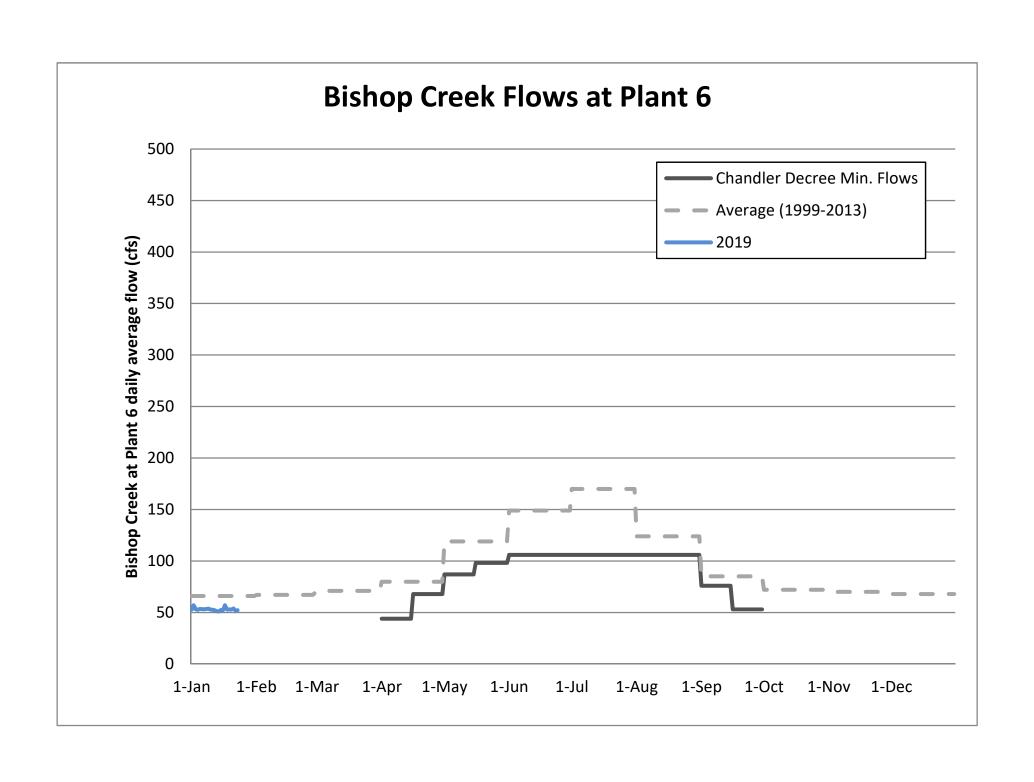

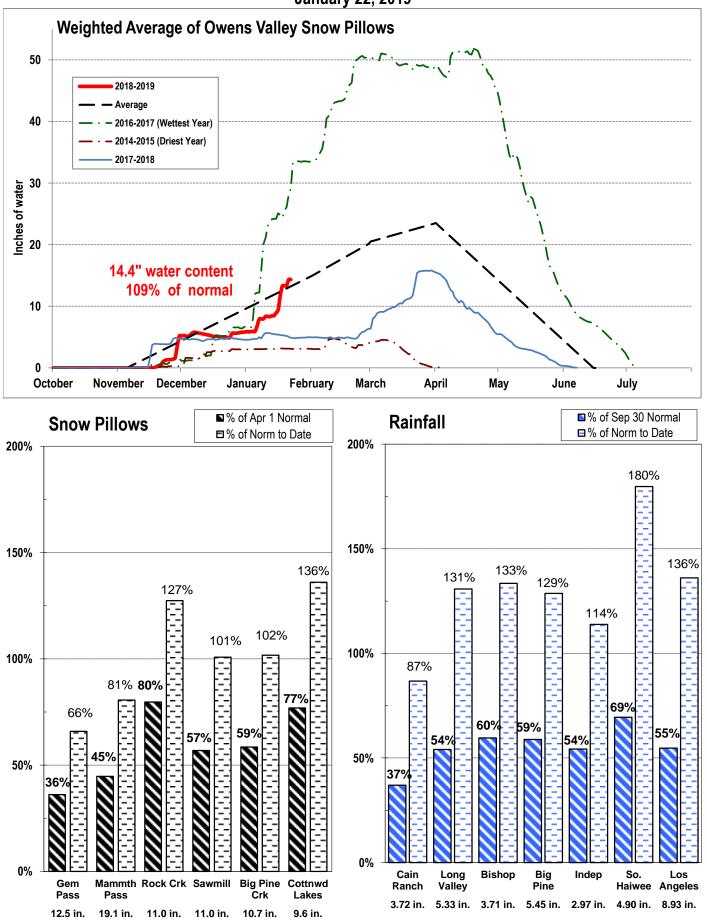
