Bishop Creek Water Association Annual Board Meeting Summary January 31st, 2022 7:00 pm Meeting Conducted via Zoom

1. Opening and Introduction

BWCA meeting called to order 7:02 pm. Trustees in attendance: Gene Coufal, Merry Armstrong, Mark Frumkin, Don Kunze and Eric Tillemans. Watermaster Matt Durkee was present. A quorum was present (see attendance list), so business could be conducted.

2. Acceptance of the January 11th, 2022 Monthly Meeting Summary

The January 11th, 2022 Monthly Meeting Summary was accepted as written.

3. Annual Report including discussion on the future direction of the Association)

Gene provided the following BCWA summary for 2021 (details can be found in the monthly meeting summaries – available on the BCWA website):

- Despite an extremely dry year SCE was able to maintain Chandler Decree flows through most of the summer.
- Typical culvert plugging problems with leaves in the fall. Board is working on a policy regarding maintenance of street culverts. The ICRD is no longer willing to participate.
- Typical ditch obstruction problems on 7 or 8 properties.
- Mapping project to identify irrigation ditches and an up-to-date data base of member properties should be completed this spring.
- Two projects are in the begin stages:1) a plan for water distribution during periods of low flow; and 2) Water Rights filing with the SWRCB.
- With regards to the future direction of the BCWA, the Board has tried over and over to enforce the BCWA By-laws without taking legal action or incurring a lot of expense. Unfortunately, in the current times we have been dealing with increasing non-compliant hostile members and government agencies. Some examples of this are: 1) ICRD no is no longer willing to assist in dealing with obstructed/deteriorating street culverts despite their use the Bishop Creek irrigation ditches and culverts for storm runoff and CWC 4037; 2) The CADFG is investigating BCWA irrigation ditch practices for none compliance with CADFG Code Section 1602; 3) Members that are non-compliant due to unpaid assessments; 4) Members obstructing ditch flows and not abiding by by-laws, and threatening lawsuit. Attempts by the BCWA Board to get support from Inyo County have been unsuccessful, leaving the BCWA to fend for itself. The BCWA as the party responsible for the implementation of the court ordered Chandler Decree will have to deal with these problems and that is going to cost, either by taking on the obligations that others are trying to impose on the BCWA

or in fighting the actions. Unfortunately fighting will move the BCWA into the arena of having to deal with these situations in a legal setting.

4. Snowpack, Precipitation and Bishop Creek Flow and Storage Report

Eric discussed the snowpack and precipitation status. He reported that 8 out if the last 10 years had been below normal. This year currently sits at 97% normal to date but only 58% of normal April 1st totals. There is a good chance that this year will end up below normal again.

5. 2021 Financial Report

Mark highlighted some items, the most significant being a big jump in attorney fees because of the issues facing the BCWA. Gene mentioned that as noted on the 2021 financial report there are currently 82 Non-Paying Members which accounted for \$12,326 in accounts receivables. (Attached)

6. Approval of 2022 Budget

Merry motioned for approval of the 2022 Budget (attached), Eric seconded it, and it passed unanimously.

- 7. Election of Trustees: (Merry Armstrong and Mark Frumkin terms expired)
 - The nominating committee recommended Merry Armstrong and Mark Frumkin to fill the two vacant Trustee positions. No other nominations were received from the membership.
 - Voting Merry Armstrong was elected by a unanimous vote of the members present to a new two-year term as a Trustee.
 - Voting Mark Frumkin was elected by a unanimous vote of the members present to a new two-year term as a Trustee.

8. New Business

- a. Gerald Berry brought up the issue of a plugged culvert at 480 Watterson St. Gene said that we would go look at the situation in the field.
- b. Don asked if it was possible to provide an online payment option. Mark will follow up to see what options thee may be.
- 9. Next Monthly Board Meeting—The Annual Meeting will take place on January 30, 2023 at 7:00 pm and next monthly meeting will be on March 8th, 2022 at 7:00 pm via Zoom.

10. Adjournment

Meeting adjourned at 8:02 pm







INCOME

Mr. Lampi,

I hope you have had a happy and healthy holiday season. I wanted to follow up with you on your most recent communications (letter of September 21, 2021 and email from September 22, 2021) as new information has come to light. This is not a complete response to all the points in your letter and email but to provide some pertinent information that you should be aware of.


- 1) I have attached three dated pictures, one from September 2013, one from June 2018 and one from April 2019 that show the open channel with generally a lack of debris in 2013, then the of accumulation of debris that had occurred by 2018 and again more by 2019. This conflicts with what has been portrayed as a "protrusion" that existed in 2013.
- 2) A survey conducted in October 2021 by Triad/Holmes Associates of the property line between the Norberg and O'Brien properties. The survey reestablished the points from the 2008 Survey conducted by Andrew Holmes in 2008 (ROS 08-004). The survey shows that the debris that Ms. Norberg has caused to be put in the Nelligan Ditch and the deck that Ms. Norberg has constructed is on the property of Terry O'Brien (sketch enclosed).
- 3) Your communications state that the Bishop Creek Water association (BCWA) does not have authority under Article IX, Section 5, as it only applies to situations where the waterflow is impeded or interfered with. Among other evidence, I am attaching a copy of a December 2021 letter from the Los Angeles Department of Water and Power which describes the impact of the obstructed Nelligan Ditch on their operations and water delivery obligations. And
- 4) Also, attached is the invoice/statement the BCWA received from the contractor that the BCWA had to hire to repair the north embankment of the structure that was compromised by the flow pattern change due to the instream obstructions upstream of the diversion structure.


As the BCWA has been given permission from Mr. Terry O'Brien to clear the obstructed Nelligan ditch channel on his property, the BCWA request that your client, Ms. Norberg, reconsider the threat of legal action in Inyo County Superior

Court and that Ms. Norberg comply with the By-Laws of the BCWA (of which she is an obligated member) and remove the debris, rocks, wood, fencing material, decking, etc. from the channel and Mr. O'Brien's property. The refusal to do so will result in the BCWA having to have the debris removed.



Subject: Water Flow in Nelligan Ditch south of Norberg Diversion

The purpose of this letter is to inform the Bishop Creek Water Association (BCWA) of the effects on the downstream flow of the ditch known as the "Nelligan Ditch" due to the structure blockage in the ditch at the diversion located adjacent to the property owned by Dee Norberg.

An analysis of flows in the Nelligan Ditch downstream of diversion located at the Norberg property, reveals a significant reduction in average flows and maximum capacity when comparing recent flows (2018-2021) to historical flows (2008-2011). This reduction is likely attributed to the blockage in the ditch just upstream of the Norberg diversion, which impedes the ability to move adequate flows through the ditch system.

Inadequate flows in the Nelligan ditch as a result of the blockage puts the City of Los Angeles (City) in a difficult position as there are obligations associated with the Inyo and Los Angeles Long Term Water Agreement to irrigate lands supplied by the Nelligan Ditch. A flow reduction in the Nelligan Ditch impairs the City's ability to properly irrigate lands supplied by the Nelligan Ditch.

A resolution of the flow issue in the Nelligan Ditch that allows full adequate flows to reach City lands through this ditch would be greatly appreciated. Please contact Mr. Eric Tillemans, Manager of Aqueduct Operations and Conservation, at (760) 873-0256 if you have any questions or concerns.

SUBJECT: Street Culvert Responsibility

Dear Bishop Creek Water Association Member,

Beginning about two years ago the Inyo County Road Department (ICRD) took the position that they can no longer assist the Bishop Creek Water Association (BCWA) in unplugging and replacing deteriorated street culverts. Previously these problems were dealt with cooperatively. This new position has left the Water Association in a quandary. The BCWA does not own assets in the water distribution system, other than structures for water control purposes. Control structures are deemed and considered the property of the association. The BCWA By-Laws Article X, Section 3 provides:

"All boxes, headgates or diversion works diverting water from any main ditch or channel, regardless of by whom installed, shall for all water control purposes be deemed and considered the property of the association. The association reserves the right to exclusively control and regulate water at all boxes, regardless of by whom the same may have been installed..."

In the past, recognizing the need to provide water to upstream and downstream water using members, the BCWA worked cooperatively with the ICRD to unplug and replace culverts. Despite numerous attempts by the BCWA Board of Trustees, Inyo County has not been willing to change from this newly taken position. This has been discussed at the highest levels of Inyo County government.

At this time, since the ICRD will no longer cooperatively participate, it is going to fall on the BCWA and its members to resolve issues with culverts in order to keep water flowing in ditches as required by the court ordered Chandler Decree. The details have yet to be worked out, but it appears that for now, the BCWA will have to be entirely responsible for replacement of culverts conveying Bishop Creek water. With regards to plugged street culverts, regardless of Inyo County's position on assisting with plugged street culverts, the BCWA By-Laws make it clear that the responsibility for keeping

ditches clean and clear of debris is the responsibility of the property owner. With the above exception, property owners are responsible for all effects, operations, and maintenance of the ditches on their property. The result of this is the keeping of debris from entering and plugging downstream street culverts. Below are some of the pertinent sections from the BCWA By-Laws that apply in this situation. Article IX, Sections 4 and 5 provides:

"Each member shall keep his ditches free and clear of debris (sand, silt, rocks, grass, weeds, and trash) so that water, including waste water, may move for the beneficial use of members below."

"In the event the equitable distribution of water is impeded or interfered with causing flooding, wastage or other detriment to the flow of water to occur by reason of the refusal, inability or neglect of any member or members to remedy the same, the association may, after due notice, have the remedial work performed and the responsible member or members shall be billed therefor, at the cost of the work."

ARTICLE XII, Section 2, items 3-6 provide:

"As a homeowner and member of the BCWA you are responsible for the impact of your own action or lack of action in managing water flowing on your property."

"As a member of the BCWA you are responsible to maintain the ditches and pipes on your property. This maintenance includes the removal of weeds, leaves, and trash ..."

"If you do not properly maintain the ditches and pipes on your property, the BCWA may arrange to have the work done at your expense..."

"Be aware that many factors, including runoff, freezing, irrigation patterns, and fall leaves, can significantly affect the amount of water flowing to your property. You should expect the flow in your ditches to vary, and your ditches and pipes should be sized, designed, and maintained to carry the maximum possible flows without flooding."

It appears that the greatest problem with plugged street culverts occurs during the fall and winter when leaves and ice get into the system, entering the street culverts. In order to keep culverts clear of debris the most effective method is a grate at the street culvert inlet. Of course, this will create additional work, but it should alleviate a lot of

headaches, work, and cost due to plugged street culverts. But for the purpose of keeping debris from plugging street culverts it is imperative that members upstream of street culverts install and maintain clear grates on inlets to street culverts. The BCWA cannot be held responsible for the installing, operation, and maintenance of grates on private property and as such the impact to street culverts. As is the case with any ditch, the BCWA must rely on each property owners to maintain a clear unencumbered channel at property boundaries and to not effect property owners immediately upstream and downstream. Street culverts are not any different.

As provide in the BCWA By-Laws, if a street culvert becomes plugged, it is the responsibility of the upstream property owner if it is plugged with leave/debris and there is no mechanism in place to catch the debris. As provided in Article IX, Section 5 (see above) in order to ensure an equitable distribution of water to all members, if the BCWA has to get involved in clearing a downstream culvert, the upstream property owner would be assessed the cost of the culvert clearing.

If you have an issue with water in your ditch, please contact the BCWA Watermaster at (760) 920-7981. You may also contact any one of the Board members for any issue related to the Water Association. Or you may bring your questions to the BCWA Board of Trustees at the monthly meeting. Sirs,

This morning, @ 10:00 am, Matt Durkee, Watermaster for the Bishop Creek Water Association and myself, Donald Kunze, Trustee for the Bishop Creek Water Association visited your property to investigate complaints from surrounding neighbors of flooding of their property due to changes you have made in the ditch running through your property. After knocking and ringing your doorbell to no avail, and along with the two large vicious dogs located in your back yard, making access to the rear of your property was made impossible to inspect what was happening to cause the ditches upstream of you to overflow. With the permission of your neighbor, we were able to look through the fence and see that you have completely filled in the ditch with gravel blocking the water from continuing to flow and causing the upstream properties to flood

Modifications such as this to the ditch system are expressly forbidden and are spelled out in the BCWA bylaws which along with this letter I am leaving for you to review. We have been forced to cut the flow of water to this ditch, drying up your neighbors both upstream and downstream of your property. Please remove this obstruction so we may again restore the flow to this ditch and the people who depend on it. Failure to do so will result in the Board of the Bishop Creek Water Association to seek a remedy that will restore the water and pass any costs on to you to accomplish this result.

Dear Bishop Creek Water Association Member,

It has recently been brought to our attention that due to an administrative error you have been left off the Bishop Creek Water Association (BCWA) rolls. This is to notify you that you will be put on the roll and will be entitled to the benefits and obligations of the Water Association. If you are not familiar with the Bishop Creek Water Association, it was formed in 1905 by the users and appropriators of the waters of Bishop Creek for use on lands located on the Bishop Cone in the County of Inyo, State of California, for: 1) the purpose of protecting their rights to the waters of said Bishop Creek; and 2) to apportion said waters among the several users. In 1922 the court ordered Chandler Decree adjudicated the waters of Bishop Creek and the diversions by the Association of Bishop Creek waters from the main canals. This caused the members of this Association to amend the Articles of the Association to conform to the changes. A copy of the amended BCWA Articles and By-Laws is attached. A copy can also be found on the BCWA website, BishopCreekWater.org.

Provisions for membership are found in Article VIII, Sections 1-3 (pages 6-7) of the By-Laws. Following is a key applicable provision:

Section 2 – " Any owner of real property whose property is traversed by, borders on, or has access to any stream, canal, or ditch carrying the water of Bishop Creek, and located within the boundaries as shown on Exhibit A, shall automatically be a member of this Association and shall be entitled to the benefits and burdened by the duties imposed herein. Any question of membership shall be referred to the Arbitration Committee, shall be binding upon all parties. "

The general rules, responsibilities, and practices regarding care of ditches and ponds are found in Articles IX, XI and XII (pages 7-13). Provisions regarding assessments are found in Article XIV, Sections 1-4 (pages 14-15).







Unfortunately, I don't think the BCWA board can be of much help as two years ago the ICRD told us that they will no long work with us to unplug or replace culverts, i.e., we are now on are own. You could bring the issue to the board at a monthly meeting, but based on BCWA practices regarding private property is that maintaining of conveyance across the subject property is paramount and it is the owners responsibility on their property. Hi Gene. I hope you are well and sorry I only seem to have the occasion to communicate with you these days are with ditch issues!

For several years the culvert that carries the Bishop Creek Water Association ditch down the west side of Mount Tom Road where it crosses the private road approach near the north end of Mount Tom has been failing. The culvert is on county right of way between my property at 397 Mount Tom Road and 379 Mount Tom Road, a house owned by the City of Los Angeles Department of Water and Power (DWP crews have been involved in clearing the culvert from time to time due to this, I guess).


For whatever reason, this winter has been hard on this culvert, sink holes have appeared, and it looks like it should be replaced soon. The neighbor that owns the property the dirt road is on (that I and some other properties use for access) thinks it had something to do with periodic flooding that came down Mount Tom Road from the south due to freezing and inadequate private ditch maintenance. I am not sure about that.

Several years ago a neighbor that moved away discussed this failing culvert with the BCWA and the county, but as far as I know those discussions never came to conclusion. I don't know the details of those discussions but you may have some record of them.

As I remember, the BCWA does not have the resources to replace failing culverts such as this but, sometimes, in conjunction with others (like the City of Bishop in my experience where as I remember the BCWA bought the materials), the BCWA could participate in the replacement. Is this still the case? Has the county participated in the replacement of culverts on their property similar to the city did? Any suggestions of how we could best approach this?
