Bishop Creek Water Association Monthly Meeting Summary October 8th, 2024 7:00 pm

1. Opening and Introduction

BWCA monthly Board meeting was called to order at 7:01 pm. Trustees in attendance: Gene Coufal, Eric Tillemans, Mark Frumkin, Merry Armstrong, and Don Kunze. Watermaster Matt Durkee was present.

2. Acceptance of September 10th Board Meeting Summary

The September 10th, 2024 meeting summary was accepted as written.

3. Approval of the September 2024 Financial Report

The September 2024 financial was unanimously approved.

4. Bishop Creek Precipitation and Flow and Storage Report

SCE continues to release low flows (approximately 50cfs). Flows do comply with Chandler Decree requirements.

5. Old Business

- a. Street Culverts
 - i. Culvert Obstruction/Blockages at:
 - o 309 Grandview: The BCWA Board sent one letter to the property owner and Gene is drafting a second letter to be sent.
 - 210 So Mtn View Rd –No water ditch for about a month due to headgate problems on the No Fork of Bishop Creek downstream of the Vista Ditch intake (see item 5b. below). Mark and Matt are working to secure the grate on the culvert at 210 So Mtn View Rd.
 - 3068 Laurel Rd Street culvert needs to be replaced. Gene will discuss with Inyo Co.
 - Matt will deliver a copy of the letter previously sent to the old owner at 255 Mt Tom Rd. to the new property owner.
 - ii. Inyo County Road Department Policy Regarding Plugged/Deteriorated Street Culverts: Gene and Eric will meet with Inyo Co. CAO, Nate Greenberg, on Thursday at noon.
- b. Failing Check Structure in No Fork of Bishop Creek at Vista Ditch: DWP will attempt a repair this fall/winter.
- c. Ditch Relocation at NW Corner of Carol Ln (Parcel no 011-510-27): No Progress. Matt will talk to the property owner.
- d. Annual Dinner: Don asked the Board to contact invitees.
- e. Water Rights Filing: No update
- f. Membership Reconciliation (mapping): Eric will perform comparison with OCR. There are approximately 20 discrepancies as of now.
- g. Collection of Past Due Assessments: On hold until database is reconciled

- h. Ditch Diversion Box Repair/Rebuild Project: On hold
- i. Bishop Tribe BCWA Membership: No update




