Monthly Meeting Summary May 13th, 2025 7:00 pm

1. Opening and Introduction

BWCA monthly Board meeting was called to order at 7:01 pm. Trustees in attendance: Gene Coufal, Eric Tillemans, Mark Frumkin, Don Kunze and Merry Armstrong. Watermaster Terry Crowl was not in attendance.

2. Acceptance of April 8th Monthly Board Meeting

The April 8th monthly meeting summary was accepted as written.

3. Approval of the March and April 2025 Financial Reports

There were discrepancies in the Accountants March and April financial reports. Mark presented his reports for March and April (attached), which were based on bank transactions rather than checks written. The Board unanimously approved Mark's reports and after discussing, moving forward agreed with transitioning to using Mark's monthly financial reports (based on bank statements).

4. Bishop Creek Vision Project – Mo Loden, LRWQCB

Mo Loden from the LRWQCB described a water quality improvement project for Bishop Creek that she is heading up. She basically has been exploring with local entities' support for the project. Discussions revolved around exploring how the BCWA might be able to assist in the project. After the Board described what the BCWA's function is she said that she may come back at a future date with some thoughts on how there might be some collaboration on the project.

5. Bishop Creek Precipitation, Flow and Storage Report

SCE significantly reduced flow in Bishop creek, down to minimal Chandler Decree levels.

6. Appointment of Water and Arbitration Committee

The board unanimously voted to approve Jan Hamiliton, Marlena Baker and Don Kunze to serve on the Water and Arbitration Committee with Merry Armstrong.

7. Appointment of Finance Committee

These appointments will be made next month.

8. Flow in Matlick Ditch

The Los Angeles Dept of Water and Power made adjustments to upstream flows in the Mattlick Ditch.

9. Old Business





After a slow start, the snowpack in the Bishop area mountains came in at about 90% of the April 1 average. Because of the recent wet years and the resulting good residual base flow, runoff from the Bishop Creek drainage for the coming Runoff Year is estimated to be 110% of normal. There should be sufficient water to meet all member needs this year.

To keep the distribution system flowing efficiently and fairly, it is important that members be diligent about keeping their ditches clear and free of debris. Debris needs to be removed from ditches and not sent downstream. And please do not tamper with headgates. It only creates problems and headaches for the Watermaster. The Watermaster has sole authority and responsibility to divert water and change flows. If you have a problem with your water, check with your upstream neighbors for obstructions or if irrigating. If the reason for the problem is not obvious, call the Watermaster for help.

Plugged and deteriorated street culverts continues to be a problem, and in fact it was probably the biggest issue that the Board had to deal with in the past year. Plugs mainly occurred in the fall when trees lose their leaves, get into ditches, move into street culverts, and get lodged. This is especially true for properties where water leaving the property enters a streetcrossing culvert. It is surprising how quickly a small branch, twig, or little bit of debris can trap more and more debris, which blocks the ditch or culvert, resulting in flooding. The best way to prevent this from happening is to screen the entrance to street culverts, preventing vegetation and other debris from entering the street culverts. Also, at locations where street culverts discharge ditch water onto private property, the water needs to flow freely as it exits the culvert.

As previously reported, the Inyo County Road Department (ICRD) has made the determination that it is not responsible for maintaining or replacing street culverts carrying Bishop Creek water and that those street culverts are solely the responsibility of the BCWA. The Board is currently discussing/negotiating with Inyo County regarding responsibility for maintenance and replacement of these street culverts.

With the mapping of the Bishop Creek Water Association (BCWA) ditches and reconciliation of the BCWA database complete, the Board is now moving forward with collection of past due assessments. This process will requires taking members who do not pay their assessments to small claims court to get a judgement against the property owner, then filing a lien on their property. This will require an amendment to the BCWA By-Laws regarding liens, which the Board is in the process of preparing. Remember that the BCWA cannot maintain the necessary distribution facilities and provide for equitable distribution of water to all its members unless members utilizing and enjoying these waters pay the assessment. The assessments cumulatively pay the Watermaster's salary, BCWA bookkeeping, maintaining adequate insurance and maintenance of an aging distribution system.

With the new BCWA maps, member property acreages can now be more accurately determined. This resulted in changes in the large property owners (10 or more acres) acreage. For some the acreage amounts changed, some parties fell off the list and some were added. At the BCWA Annual Meeting in January membership approved a budget that called for no change to the annual assessment for individual parcels and reduced the per acre assessment rate for large landowners from \$2.90 per acre to \$2.50 per acre. This assessment rate change maintained a neutral income and also maintains the current ratio of income from large property owners compared to individual parcels.

For reports on the progress of other ongoing activities and issues, i.e., water rights filing, structure repairs, ditch obstructions, etc. see the monthly Board meeting summaries posted on the BCWA website (www.BishopCreekWater.org).

Lastly, we want to extend thanks to the Los Angeles Department of Water and Power (LADWP) and Southern California Edison, for their efforts and cooperation, and to all the BCWA members for their continued help and support. We want to especially thank LADWP staff for performing the secretarial duties of the BCWA. As a final note, we want to give a special thanks to Watermaster Matt Durkee, who has resigned. He has been our Watermaster for the past 8 years and has done a wonderful job. He will be missed. He has been replaced by Mr. Terry Crowl, who brings significant experience in surface water management to the job. The Watermaster's phone number has not changed and is listed below.

The Board continues to meet on the second Tuesday of each month at 7:00 pm. You can find upcoming meeting agendas and packets, and information/announcements on operations on the BCWA website. All members are invited to participate and are encouraged to provide input on any water association related issue. The monthly board meetings are currently being conducted in the George Lozito Conference Center at the Jill Kinmont Booth/ICOE facility at 166 Grandview Drive.

Again, if you are having issues with your ditch water call the Watermaster. If you have any questions about the above or any other BCWA matter, please do not hesitate to contact one of your Board members listed below. Again, thank you for your support. We are here to serve the BCWA membership.

Dear Ms. Gamino,

By letter dated May 15, 2018 (attached), then Director of Public Works, Mr. David Grah, requested information regarding the assessment the City of Bishop (COB) receives from the Bishop Creek Water Association (BCWA). The letter specifically questioned the assessment on parcel 008-080-09. Thank you for your patience and please except our apology for the lengthy delay in responding to this request.

If you are not familiar with the Bishop Creek Water Association, it was formed in 1905 by the users and appropriators of the waters of Bishop Creek for use on lands located on the Bishop Cone in the County of Inyo, State of California, for the purpose of: 1) protecting their rights to the waters of said Bishop Creek; and 2) to apportion said waters among the several users. In 1922, the court ordered Chandler Decree adjudicated the waters of Bishop Creek and the diversions of waters from the main canals by the Association of Bishop Creek. This caused the members of this Association to amend the Articles of the Association to conform to the changes. A copy of the BCWA Articles and By-Laws can also be found on the BCWA website, www.BishopCreekWater.org.

Provisions for membership are found in Article VIII, Sections 1-3 (pages 6-7) of the By-Laws. The following is a key applicable provision:

Section 2 – "Any owner of real property whose property is traversed by, borders on, or has access to any stream, canal, or ditch carrying the water of Bishop Creek, and located within the boundaries as shown on Exhibit A, shall automatically be a member of this Association and shall be entitled to the benefits and burdened by the duties imposed herein. Any question of membership shall be referred to the Arbitration Committee, shall be binding upon all parties. "

The reason for the delay in responding to COB request was mainly due to a lack of historic documentation regarding the COB account. What we can tell you is that the above-mentioned parcel was used as a place holder in the BCWA billing data base to represent applicable COB properties. In addition, thanks to a recently completed mapping project we are now equipped to address issues regarding membership and boundaries within BCWA's jurisdiction.

We could not find any documentation to explain past assessments, however with the currently available data we are able to identify the COB properties that are crossed by ditches conveying Bishop Creek water and therefor subject to the BCWA Articles and By-Laws.

Our mapping and records indicate that 3 parcels, 008-260-02, 011-360-02, and 008-140-28, have ditches conveying Bishop Creek water across them. At the current assessment rate of \$40 per parcel, the City of Bishop will be assessed a total of \$120 for 2025. The COB will receive 3 invoices in early May, one for each parcel.

Again, sorry for the delay. I hope this answers the City 's questions. If you have further questions or other information regarding this, please contact me on (760) 873-6209.


Hi Gene,

Hello.

Per the BCWD Bylaws, we are writing to inform you of our intended use of ditch water for this spring, summer and fall at our 3613 Ranch Road full-time residence .

As you likely are aware, we are one of the properties in the system that still flood irrigates; we do not have a sprinkler system. It has been our practice over the past 27 years to flood irrigate on Mondays and/or Thursdays. Depending on water supply and climate, we plan to continue with that practice. In the event we need to amend that schedule, we will notify the WaterMaster.

It is our goal to minimize the impact on water users downstream. To that end, the greater the flow when we are flooding, the shorter the period of time that we will need to divert the main ditch. As such, we ask that the WaterMaster assure that properties upstream are not diverting flow while we are flooding. In the event we suspect that upstream diversions are reducing flow in the main ditch, we will first check the ditch above us. If the ditch appears to be clear of debris and/or diversions, we will contact the WaterMaster for a remedy, as stated in the BCWD Bylaws.
